 - b. Three officers (sl.no. 1-3) of the above team will leave Canada on 21 April 2025 or on a date nearby for visiting the Bangladesh Missions in the United States of America (USA) from 22 April 2025 to 28 April 2025 or 7 (seven) days from the date of leaving Canada. They will coordinate with Bangladesh Missions in USA for conducting voter registration and issuing National Identity Card to the expatriate Bangladeshi citizens and exchange views with the Bangladeshi community and officers related to these programs.
 - c. They will leave Dhaka on 13 April 2025 or on a date nearby. The officers under sl. no. 4 and 5 will return to Dhaka on 23 April 2025 or on a date nearby and the officers under sl. no.1-3 will return to Dhaka on 30 April 2025 or on a date nearby after visiting Canada and the USA.
 - d. The period of this tour and time spent for travel and transit will be treated as on duty.
 - e. They will draw their usual pay and allowances in local currency and no part of it should be drawn in foreign currency.



- f. All expenses of the admin team (sl. no. 1-5) regarding this visit will be borne by IDEA Project (Phase-2), Election Commission Secretariat.
